5.2 The Panel agreed to accept the Visitors' Reports for the following programmes, including the conditions recommended by the Visitors:

# Item 6.06/97 VISITORS' REPORT AND REPRESENTATIONS

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel noted that the MA Integrative Arts Psychotherapy programme at the Institute of Arts in Therapy and Education (IATE) had been the subject of an approvals visit on 12-13 July 2006. The Visitors' report had been sent to the education provider, which had made representations about the report.
- 6.3 The Panel noted that the education provider had made representations about the condition in the report under Standard of Education and Training 5.6. The condition required that IATE should provide detailed information on how visits to placements would be developed and implemented as part of the education provider's system for approving and monitoring placements.
- 6.4 The Panel noted that the education provider agreed with the spirit of the report and would be implementing visits to placements in the autumn 2006 term. However, the education provider did not want to make a commitment to visit each placement every year because the provider felt that this would be unmanageable, with the amount of placements including those in Brighton and Bath.
- 6.4 The Panel agreed that it was not unreasonable for the education provider to visit the placements every year, particularly as locations such as Brighton and Bath were readily accessible from London and the proposed student cohort was relatively small (20 students).
- 6.5 The Panel noted that the education provider had also made representations about the condition in the report under Standard of Education and Training 3.12. The condition required that IATE should clarify how it ensured that students had access to adequate resources in placements.

- 6.6 The Panel noted that the education provider had stated that it had done a considerable amount of work in auditing placements and resources, but did not think it was possible to create an exact parity of practice as each context was so different. The Panel noted that the education provider had stated that students supplied their own art materials and were happy to do so. The education provider had stated that it did not want to stop placements happening because placement providers did not have resources to provide equipment.
- 6.7 The Panel agreed that it was unreasonable for the education provider to expect students to provide their own materials. The Panel agreed that the education provider should make arrangements with placement providers to ensure that students had access to adequate resources.
- 6.8 The Panel accepted the Visitors' report, including the conditions recommended by the Visitors.

#### Item 11.06/102 HPC ANNUAL MONITORING AUDITS FOR APPROVAL

- 11.1 The Panel noted that the HPC annual monitoring cycle took place annually and involved two types of monitoring submissions over a two year period. The Executive had divided education providers in two groups. In 2006, all programmes in Group B had been required to complete an audit form and submit it with their internal quality reports and external examiners' reports from the last two academic years.

- 13.3 The Panel noted that the programmes listed in the paper were due to have an approvals visit in the 2006-7 academic year and as part of the HPC's "light touch" approvals and monitoring process, it was felt to be more appropriate that the Visitors' requests for more information should be considered as part of the forthcoming visits. The Panel noted that the reports from the annual monitoring assessment days would be shared with the Visitors undertaking the approvals visit and the education provider.

- 13.5 The Panel noted that the annual monitoring process for the 2005-6 academic year had now been completed.
- 13.6 The Panel noted that some education providers had given feedback on the process, raising issues such as the information which should be submitted to the HPC. The Panel noted that the Approvals Committee had agreed to amend the process, so that programmes would not be subject to annual monitoring if they had been subject to an approvals visit in the previous academic year or were going through the approvals process.

# Item 14.06/105 ANY OTHER BUSINESS

- 14.1 The Panel noted that one of its members had been contacted about a programme which had submitted a proposed change, under which first year students would have more teaching in a clinical environment rather than at the education provider. The Panel noted that the proposal affected less than 25% of the programme and was therefore categorised as a minor change. However, it was thought that the change might adversely affect students' understanding of the philosophy of the profession.
- 14.2 The Panel noted that the programme concerned had not yet been approved by the HPC and the Executive and appointed Visitors were involved in ongoing work to resolve issues relating to the programme.
- 14.3 The Panel noted that the Executive was aware that the major and minor change process might require some revision. The Panel noted that the Executive intended to review the process in spring 2007.
