Executive summary and recommendations

#### Introduction

Mr D S Sidhu of the National Audit Office wrote to the Chief Executive on 29 January 2008, to explain that he had been asked to become lead director for the financial audit of the Department for Children, Families and Schools. Mr Dean Parker has taken over most of Mr Sidhu's existing responsibilities, including the HPC, from 1 February 2008.
