Risks from contracts without a service level agreement in place

Executive summary and recommendations

Introduction

At the September meeting, a paper was presented to the Committee identifying HCPC's contracts with an expected value over £100k, noting whether the contract includes an SLA and, if so, whether the SLA is being actively managed.

The Committee asked the Executive to return in November with an assessment of the risk arising from the contracts that do not have an SLA in place.

The analysis shows that there are some significant contracts for which an SLA would be appropriate but we do not currently have an SLA. In all but one of the listed cases we are either in the process of moving to a framework agreement including an SLA, or we plan to do that within the next year, so the risk arising from not having an SLA in place is low.

We do promote the use of SLAs within contracts through procurement support to budget holders.
