Public Affairs and Stakeholder Report

Executive summary and recommendations

Introduction

The new Public Affairs Manager has been working on various stakeholder activity plans since her appointment in May 2007. The bulk of work so far has focussed on employers and Parliamentarians as priority stakeholders and the next step will be to provide a co-ordinated approach to working with professional bodies and increasing stakeholder activity in the four home countries.

The first attachment shows our employer activity plan which aims to promote our key messages to employers and to keep them informed and engaged with the HPC. Employer Events and a new section on the website dedicated to people who employ health professionals on our Register are two examples of work in the activity plan.

The second attachment is a stakeholder activity plan for Parliamentarians. This aims to raise awareness of our work amongst Parliamentarians across the four home countries. This will be achieved through various channels such as activity at annual political party conferences, hosting Parliamentary roadshows, and mailing of appropriate briefings and public awareness work.

The third attachment contains information about other stakeholder group activities including work with professional bodies and meetings with stakeholders in Belfast.

Stakeholder activity plan – Employers

Summary

This stakeholder activity plan is designed to help the HPC achieve its communication objective to influence the regulatory agenda through ongoing dialogue and engagement with key stakeholders.

It aims to promote the HPC's key messages to employers and to keep them informed and engaged with the HPC across all activities and on specific issues. It also aims to identify perceptions and views amongst employers and develop a programme of relationship and contact building to improve perceptions, increase understanding of the work of HPC and the role of the employers.

- identify key parliamentarians across the four home countries and develop appropriate channels of communication
- raise awareness of HPC to Parliamentarians through appropriate channels

Next steps

The next step is to evaluate this programme of work and develop the next phase of communication with Parliamentarians which will take place in 2008-2009. Evaluation methods will include number of visits to the SNP Annual Conference exhibition stand, number of visits to

the exhibition stand in Scottish Parliament, feedback from mailout of campaign material to MPs constituency offices and meetings with Parliamentarians.

Stakeholder activity plan – Other groups

Professional bodies

The HPC has already done a lot of work with professional bodies although it is now the responsibility of the Public Affairs Manager to coordinate communications with this important stakeholder group. The Chief Executive sent out a letter to all professional bodies on 30 August regarding the annual meeting with HPC asking them whether they are happy to continue to meet at Park House or whether they would prefer a representative from HPC to attend their board meetings. Many of the professional bodies have responded and HPC representatives will meet with them towards the end of 2007 or at the beginning of 2008.

Next steps

The Public Affairs Manager will be present for all these meetings and will use them as a starting point to assess and determine the most appropriate way forward in establishing a co-ordinated programme of communications activities which will ensure that we are continuing our dialogue with this important stakeholder group and that they are receiving relevant and consistent information about the HPC.

Stakeholders in Home Countries

Northern Ireland

The Public Affairs Manager and Director of Policy and Standards visited Belfast in Northern Ireland to meet with various stakeholders in mid-September. The purpose of the trip was to build links with key stakeholders, improve communication channels and find out about any specific Northern Ireland issues. This trip was part of the broader communications objective to influence the regulatory agenda through ongoing dialogue and engagement with key stakeholders.

The reason that these stakeholder meetings took place in Northern Ireland over other home countries was because the Director of Policy and Standards was asked to give a CPD talk in Belfast. We therefore thought it would be a good opportunity to make the most of the visit and meet with other key stakeholders at the same time. During the same week the Chief Executive was also asked to speak at a Northern

Ireland White Paper Stakeholder Event hosted by the Department of Health, Social Services and Public Services. The Public Affairs Manager and Director of Policy and Standards also attended this event and met with key stakeholders.
