2	Extending professional and occupational regulation: Committee agreed to feed back the following points to the Council: - statutory regulation could be seen by some as giving an equivalent clinical legitimacy or perceived evidence base to that of groups which were already regulated. However, HPC's primary concern should be whether extending statutory regulation would increase public protection. The Committee felt that the impact of statutory regulation on perceptions of a group should be debated by the Council and then discussed at external events; - there was potential for tension between the HPC's new professions process and an eventual decision by government on which professions should be regulated.
