## 11 July 2006 APPOINTMENT AND REAPPOINTMENT OF COUNCL MEMBERS TO COMMITTEES

# **Executive Summary and Recommendations Introduction**

In July 2005 following the first Council Elections Council agreed the following processes for the appointment of members to committees;

- (i) Process for the Appointment of Members to the Education and Training Committee
- (ii) Process for the Appointment of Members to Practice Committees
- (iii) Process for the Appointment of Members to the Non-Statutory Committees

All of these processes dealt with the situation whereby all Council members were newly elected and the all the committees were seeking a completely new membership.

The completion of the terms of office of the registrant Physiotherapy, Occupational Therapy and Radiography member on Council on 8 July 2006, 3 lay members and the resignation of the alternate Radiography member has created vacancies on a number of committees;

Council will need to consider if it wishes;

- (i) to reappoint members who are re-elected and re-appointed to the committees on which they were previously members to continue for the remainder of their original two year appointment i.e. until July 2007
- (ii) to appoint the new Council members to the vacancies created by the member they are replacing for the remainder of the original member's two year term of office i.e. until July 2007
- (iii) to appoint members to the Fitness to Practise Committee for two years<sup>1</sup>
- (iv) to agree that if a new lay member is appointed to Council to replace Ros Levenson (who has resigned), that member should be appointed to the Health Committee. In the absence of a new lay member, nominations should be sought from among the current lay members, the President to make the final recommendation to Council<sup>2</sup>.

The advantage of the above proposal is that it would simplify the re-appointments process to most committees which will be undertaken in July of next year (and every two years thereafter) when the terms of office of the majority of committee members will come to an end.
