APPOINTMENT AND REAPPOINTMENT OF COUNCIL MEMBERS TO COMMITTEES

Executive Summary and Recommendations

Introduction

In July 2006 Council agreed to appoint new Council members to the vacancies created by the member they are replacing for the remainder of the original member's term of office.

At its meeting on 31 May 2007 Council agreed that, in view of the likely timetable for the implementation of the governance changes proposed in the White Paper, the process for reappointment to committees would not take place at 9 July 2007 Council meeting and that therefore the membership of committees would remain unchanged. However that if it became obvious that the implementation timetable for the White Paper was not proceeding as planned Council would be asked to reconsider this issue.

Mr Robert Clegg and Mr Tony Hazell have been re-appointed to Council for 4 years from 9 July 2007. Miss Pam Sabine has been re-appointed to Council, following her recent re-election, for 4 years from 9 July 2007. In view of the 31 May 2007 Council decision all of the above members will continue on the same committees as currently unless they agree to swap with another member.

New Appointments following the 2007 Elections

Mr Neil Willis was appointed registrant Biomedical Scientist member, in place of Mr Morgwn Davies, and Mr John Donaghy was appointed registrant Paramedic member, in place of Mr Pat McFadden, by Council following the completion of the 2007Council elections.

In line with Council's decisions regarding committee membership it is proposed that Mr Willis and Mr Donaghy take Mr Davies and Mr McFadden's place on the following committees;
