Members' Register of Interests

Executive summary and recommendations

Introduction

- The Health Professions Order 2001 requires the Council to establish and maintain a system for the declaration and registration of the private interests of its members and the members of its committees. To that end, a declaration of interests form was introduced at the inception of HPC and all new Council and Committee members are required to complete the form on their appointment to or by the HPC.
- If members are participating in Council or Committee business where they might have, or be seen to have, an interest in the outcome or any interest which could otherwise prejudice their decision, that interest should be declared through their declarations of interest form and at the start of each Council and Committee meeting.
- 3. It has become apparent that other public authorities have adopted a form which provides more comprehensive disclosure with regard to membership of public bodies and declaration of gifts and hospitality and so, in accordance with HPC's commitment to transparency and openness and to ensure that the HPC remains in line with current best practice, a review of the current register of interests form has been carried out.

Proposal

4. Appendix A shows the proposed new register of interests form. As you will see, the proposed paperwork would allow more detailed disclosure relating to membership of bodies, including those to which a member is appointed by the HPC, and a specific area to disclose any gifts or hospitality received by members in their capacity as such.

Decision

- 5. Council is asked to:-
 - (i) approve the revised declaration of interests as attached at appendix A; and
 - (ii) agree that all members must submit a revised declaration of interests form by 1 November 2010.
