1. Human Resources

No changes.

The Business Process Improvement section moved from the Mezzanine floor to a part of Park House with the Operations Director in early March.

2. Quality Management System (QMS) review meetings and internal audits

The internal audit schedule for 2010 – 2011 is running. The new archive at Deepstore in Cheshire has had a second audit by Tom Berrie and was found to be secure. Greg Ross-Sampson and Roy Dunn also attended to evaluate security and risk factors.

Tom Berrie has audited additional key suppliers, including Europa Quality Print and will continue this function.

2. QMS process updates

Project prioritisation processes are being reviewed with the IT, Operations and Chief Executive.

Some processes are being moved to "company wide" processes under the Chief Executive's control.

3. BSI Audit

The next ISO9001:2008 audit will be on 5 April with our new auditor, John Doyle, looking at international registrations, the whole Quality Management System function at HPC, plus workplace and IT provision.

4. Business continuity

There are no changes currently other than monthly list updates. Planning for the 2011 three-day exercise is ongoing.

An exchange of ancillary banking items in the HPC war boxes has taken place to following the move from NatWest Bank to Lloyds Bank.

Further changes will be required when the debit/credit-card charging Semafone PCI-DSS compliant solution is rolled out to the business.

5. Information security management

Customisation for our cross-organisation information security training solution have been delivered. Approximately 80% of employees have login details. Pass-marks of 70-100% are being achieved.

An interactive All-Employee Meeting presentation on Information Security was delivered on 23 February. This also introduced the online training solution. A low-level competition highlighted some key elements of the information security standard.

A new information asset classification policy (ISO27001 deliverable) has been signed off by EMT. This is being shared with the Fitness to Practise Department to develop their internal document classification.

6. Information & data management

BPI and the Registration Department have looked at possible scanning and presentation systems to speed up CPD and international/grandparenting assessment processes. Security is of course highly important. A trial of the system in house with CPD assessors was successful.

Trial restoration of historic hard copy registers is underway since early February. Documents are currently being cleaned and neutralised, before rebinding.

7. Risk register

The February 2011 update to the risk register has been circulated to the Audit Committee.

Specific risks around implementing HPC's actions from the White Paper "Liberating the NHS: Report of the arm's-length bodies review" and are included in the current published version.

1. Media and Public Relations

Media releases issued in this guarter include the launch of the HPC's new information about the fitness to practise process which highlighted the new fitness to practise (FtP) visual presentation. Ten releases were issued on FtP hearings on strike off and suspension outcomes from early January to March 2011.

For the month of January we had 99 mentions across national and regional media regarding FtP hearings. We had 8 mentions on general HPC issues, 6 mentions related to social workers, 2 mentions from monitored blogs and 13 mentions in professional body publications.

For the month of February we had 93 mentions across national and regional media regarding FtP hearings. We had 16 mentions on general HPC issues, 8 mentions related to social workers, 29 mentions on the Command paper, and 24 mentions in professional body publications.

The implementation plan for the organisation's social media strategy is nearing completion and we are progressing the elearning module with Citizens Advice Scotland.

The referrers' campaign has been extended to the end of March. The content on the microsite has been refreshed and the campaign is featured in the weekly bulletins to GPs. To date, 3,418 doctors have visited the microsite 5,925 times which is an average of 1.7 visits per doctor.

The February direct mail campaign of our public information materials to Patient Advisory Liaison Managers, Community Health Councils and other patient groups went ahead as scheduled.

The Google adwords campaign is resulting in an average of 73 people a day clicking through to our website. We continue with our sponsored advertising on thomsonlocal.com encouraging members of the public to check that their chiropodist/podiatrist and physiotherapist is HPC-registered. Our targeted Yellow Pages directory advertising continues for these two professions also

The Media and PR Manager is scheduled to meet the Chartered Society of Physiotherapy to discuss taking forward a protection of title campaign.

Planning for the party conferences in 2011 is continuing with our membership of Health Hotel now confirmed. Meetings will take place in March where we will discuss the issues we want to address at this year's conferences.

We met the GMC to begin planning a joint parliamentary researchers' event in the Scottish Parliament. This will take place in the autumn and will include other health and social care regulators.

Monitoring parliamentary traffic continues to increase; this is largely due to the Parliamentary scrutiny of the Scotland Bill, the Health and Social Care Bill and February's Command Paper on the future of health regulation.

Annual meetings with professional bodies have been taking place with support provided by Communications to the Chief Executive and Chair.

We are currently working with the Policy and Standards and Registrations departments to submit a response the European Commission on the review of Directive 2005/36/EC (recognition of professional qualifications). In support of this work we attended a one day public hearing in Brussels supporting the Chief Executive.

3. Web

The fitness to practise section ('complaints') has now been relaunched with new content and structure. The revised content reflects our new publications in this area, while the new structure focuses on providing relevant information for the different audiences (registrants, representatives, employers, witnesses and the public).

The latest website deployment is currently in user acceptance testing. This deployment includes improvements for the events information and the addition of RSS feeds for our news stories and press releases.

The project to develop the hpcheck.org microsite is now in the 'Technical Assurance' phase. This work includes assessing the security risk of the new architecture and identifying mitigations to reduce or remove the risk.

4. Publications

We are currently working on producing:

We have started planning the next series of events to run in 2011 - 2012 including preliminary work on social work specific events.

The first of the renamed Meet the HPC Events will take place in Anglesey and Derry in March 2011. Preparations for the 2011 – 2012 series of Meet the HPC events are underway with dates and locations confirmed.

6. Internal communications

We published issue twelve of HPC Update on Wednesday 23 February at the all employee meeting. We also completed an internal survey to improve this form of internal communication moving forward.

The next All Employee meeting will take place on Friday 8 April and preparations have begun for the All Employee Training Awayday which will take place on 20 May.

7. Communications work for organisational activities Transfer of social workers (England) Register: activities in this quarter have included:

The Chair and Chief Executive participated in two social work conferences organised by the GSCC. Members of the communications team provided support, and attended both conferences and participated in the afternoon workshops.

We have submitted written evidence to the Health and Social Care Bill Committee; our response provided further information on a range of key issues relating to the transfer, was supportive of the Bill and highlighted our commitment to working closely with the GSCC and other stakeholders.

We have provided written briefings on a range of issues for the Department of Health to brief Ministers when the relevant section of the Bill is discussed by the Public Bills Committee in March.

1. Approval process

As expected, based on the figures for previous years the peak of approval activity for this academic year takes place between January – June 2011. There are currently 30 visits reviewing 50 programmes scheduled from April – September 2011. This includes a number of small scale multi-professional visits and one large scale multi-professional visit covering five professions. The schedule of visits is now closed until October 2011, as we require six months notice.

Following the approval review day on 11 January 2011, a summary report was presented to the Education and Training Committee on 10 March 2011.

2. Annual monitoring process

The Department has spent the last couple of months preparing for the annual monitoring assessment days in the 2010 - 2011 academic year. The first assessment days took place on 1, 22 and 24 March 2011, with further assessment days planned for week commencing 23 May 2011 and 27 June 2011. The revised SETs are in use for the 2010 - 2011 cycle of annual monitoring.

The deadlines for this year have once again been batched to improve process efficiency and ensure that internal quality processes have been completed. The upcoming deadlines fall at the following times:

Friday 29 April 2011 Tuesday 31 May 2011 Thursday 30 June 2011 Friday 29 July 2011 Wednesday 31 August 2011 Friday 30 September 2011 Monthly reminders continue to be sent to ensure submission of documentation from education providers.

Following the annual monitoring review day on 29 October 2010, a summary report was presented to the Education and Training Committee on 10 March 2011.

3. Major change process

Following the decrease in the number of major change notifications received towards the end of 2010, we have received a high volume of major change notifications since January 2011, but they are progressing well and being processed to the required timescales. Since the last Council meeting on 10 February 2011 we have received 27 new major change notifications, covering 24 programmes.

Following the major change review day on 19 October 2010, a summary report was presented to the Education and Training Committee on 10 March 2011.

4. Practitioner psychologists

The Department has spent the last month scheduling the 24 practitioner psychologists' visits across 32 programmes, which are due to be held in the next (2011 - 2012) academic year. 10 out of the 24 visits (42%) have now been scheduled and we have until December 2011 to schedule the remainder.

5. Hearing aid dispensers

There are no updates specific to the Department since the last Council meeting on 10 February 2011.

8. Social workers (England)

Members of the Department continue regularly to meet the General Social Care Council (GSCC) Social Work Education Group. Regular two monthly meetings have been established to discuss the transfer of approved programmes and implementation of our approval and monitoring post transfer. The focus for these meetings is social worker pre-registration programmes, as well as approved mental health professional programmes (a post-registration qualification that is likely to result in annotation to our register).

Members of the Department have also met a wider range of social work stakeholders, including the British Association of Social Workers and Social Work Reform Board Education Working Group. A presentation was also given at the UK Standing Conference of Stakeholders in Social Work Education.

9. Communications with education providers and stakeholders

10 Partners

Members of the Department were involved in interviews to recruit new occupational therapist and hearing aid dispenser partners, which took place in February 2011. Three occupational therapist visitors and one hearing aid dispenser visitor were successfully recruited and will receive new visitor training in July 2011. Further recruitment for chiropodist, paramedic, physiotherapist, speech and language therapist and radiographer visitors will take place in May and June 2011.

11. Employees

Following the interim structure adopted by the Department between January – April 2011, a revised permanent structure is anticipated in the 2011 - 2012 financial year. Information on this will be presented to the next Education and Training Committee meeting on 9 June 2011.

1. General

Since the last Council meeting, the Finance Department has produced the management accounts up to January 2011.

2. Nine-month forecast

The nine-month forecast has been completed and the results are shown in the year to date and year end position forecast columns on pages 3, 5 and 8. The forecast operating surplus for the year is expected to be £329k compared to the original budget surplus for the year or £20k.

3. Supplier payments

At the end of January, 97% by value of the £461K Creditor payments were in the 30 days or less category.

4. Fee adjustments and income receipts handling

At the end of January, there was no backlog in registrant direct debit cancellations and amendments against a two-day backlog target. We had no backlog on rejected payments/refunds against a two day backlog target and no backlog on mid-cycle lapsing of registrants. The banking of registrant cheques is up to date and there was no backlog on credit-card reconciliations against a two-day backlog target.

5. Income collection cycle

Direct debit collections of registrants' fees (cover approximately 80% of registrants) are processed by the Finance Department, with collections made two months in advance. Paramedic, orthoptist, radiographer, clinical scientist, prosthetist and orthotist and speech and language therapist collections occurred in January and February. Physiotherapist and

6. Funds under management At the end of January 2011, £4.1M was invested in Lloyds

occupational therapist collections are scheduled for March.

Most of the income comprises of renewal fees collected.

instant access account and £209k was invested in the Nat West Special Interest-bearing Account (SIBA), both earning 0.50% per annum. The following have been invested for 3 months (maturing end January 2011) at fixed rates: £0.5M invested in Barclays money market account earning 0.60%, £0.5m invested in Nat West deposit account earning £1.25% and £0M in Lloyds TSB money market account earning 1.25% (Note: Due to Money market rules the £3.0M with Lloyds matured on 31 January and was automatically transferred to the Lloyds instant access account. This was put back on the money market on 1 February).

The investment portfolio (excluding £162k portfolio cash) at the end of January was valued at £2.06M. The investment portfolio value including cash & money market instruments was £2.23M. This compares £2.07m at the start of the financial year. Update: Following the Council decision in February and best advice from Rensburg Sheppards, the investment portfolio was fully realised and funds of £2.25M were credited to HPC bank accounts on 2 March.

7. Pensions

In September, there were 65 active members in the Friends Provident. Flexiplan pension scheme update: HPC has now had official notification of the operational financial charges for the Flexiplan scheme. From 1 April 2011 a monthly payment of

£4,495.90 will be made as our contribution to the funding deficit. The latest update indicates that the test court case to determine the overall liability is not expected to take place until early 2012.

8. 22-26 Stannary Street Ltd.

Notification has now been received from Companies House that 22-26 Stannary Street Limited had been dissolved effective from 1 March 2011.

9. Employee training and levels

There are eight full-time employees in the Department. Temporary employees are periodically hired to cover for employees on annual or sickleave and to help achieve Finance Department service-level targets.

10. Sage system support and development

The finance team is working with TSG, our Sage service provider, to work through the details of the Sage accounting system enhancements. A new version of Sage is planned for next financial year, together with PRS enhancements.

Significant Financial Projects/Issues (next few months)

 The purchase order product, PRS, has been reviewed by the finance team. It is planned to role out a new version of the product next year at the same time as a new release of the Sage accounting system. PRS is a product of Sicon who are now a Sage business partner. This will improve compatibility between the accounting and purchase order systems. Following a visit to Sicon by HPC Finance team and TSG (HPC's Sage retailer), a fixed asset module has now been installed in HPC offices which offers improved asset management including reporting and depreciation accounting integrated with Sage accounting program. This has now been activated, populated with live data and assets verified in preparation of the financial year end.

1. Number of allegations

In January and February 2011, 140 Allegations/enguiries were received.

2. Number of open cases pre-Investigating Committee Panel

At the end of February 2011, there was an open pre-ICP case load of 375 cases. At the start of the financial year, there were 390 cases.

3. Length of time

For cases that have been considered at Investigating Committee panel between April 2010 and Feb 2011, the mean and median length of time was 6 and 5 months.

At the end of February 2011 there were 51 cases over 5 months old where the request for observations from the registrant had not been sent. In 45 of those cases we are waiting for information from third parties (this includes waiting for information where a police or employer investigation has not vet concluded.

4. Case to answer percentage

Of cases considered by an Investigating Committee panel between April 2010 and February 2011, the case to answer percentage was 57 per cent. Taking into account cases that are closed before consideration by an Investigating Committee panel (for instance as they do not meet the standard of acceptance for allegations), the percentage of cases that were referred to final hearing in the same period was 38 per cent

5. Number of cases awaiting hearing

At the end of February 2011, there were 237 cases awaiting consideration by a substantive panel. 125 of those cases have a hearing date or proceedings have started but not concluded. There were a further 34 cases that were ready to fix. There were 7 cases over five months that are not ready to fix and in those cases a number of complex issues that have arisen since their referral by the Investigating Committee.

6. Length of time

Of the cases that concluded at final hearing between April 2010 and February 2011 the total length of time taken for a case to conclude is a mean of 15 months and a median of 14 months which compares to a mean and median of 18 and 16 months for 2009-10.

7. Protection of title

Between April 2010 and February 2011, 278 complaints about misuse of title have been received. At the end of February there were 52 open cases.

8. Registration Appeals

Six new appeals were received during February 2011. Registration appeals have been listed for hearing in Edinburgh on 1 April 2011.

9. Health and Character

56 new health and character declarations were received in January and February 2011. At the end of February there were 61 open cases

12. Other

The CHRE audit of the initial stages of HPC's fitness to practise processes took place in December 2010. We are expecting the final report to be published at the end of March 2011

Work continues on the development of the case management system with a number of meetings and workshops taking place with developments and contractors involved in the implementation of the system.

1. Employee resourcing Communications

Interviews for the replacement post of Communication Officer (Events) were held in February. Samantha Herelle was appointed and starts work at the HPC in late March.

2. Fitness to Practise

Recruitment is in progress for the new posts of Hearings Manager and Hearings Officer, and the replacement post of Lead Case Manager. Interviews for all three posts will take place in March.

3. HR and Partners

Sam Ha, HR Co-ordinator, has returned to work part-time following her maternity leave. Marche Wilson, who was seconded to cover the maternity leave, has returned to her role as Partner Administrator.

4. Registration

Interviews were held for a replacement role of Registration Adviser in February. Tameka Anthrobus was appointed and started work on 28 February.

5. Other HR activities GSCC Transfer work

Preparation for the announcement of the HR implications of the GSCC transfer, and follow up work including question and answer sessions, publishing of FAQs on the intranet, advice

to line managers and employees, and planning of further work, has been a key area of activity for the HR Department since the Council's last meeting.

6. Training

The HPC's management development programme is continuing, and the HR team is now in the process of analysing training needs identified during the APDRs (Annual Performance Development Reviews) which were due to be completed by the end of February.

Diversity training for nine recently appointed employees was held on 4 March.

7. Policy work

The HR team has reviewed the HPC's policy for bank holiday entitlements for part-timers to ensure that all part-time employees receive the appropriate proportion of bank holidays compared with the entitlements of full-time employees. We have also drafted new criteria for the annual Employee of the Year award to be considered by the ECG (Employee Consultation Group).

8. Review of pay policy and process

Work around management of the annual pay review including provision of information for managers and for the Remuneration Committee has taken place over January and February, in addition to consultation on the new pay policy.

Information Technology – Mr Guy Gaskins

Strategic objective 1 – "To drive efficiencies within the organisation by the use of Information Technology and Information Systems."

Database Upgrade

A project to upgrade a number of databases to a more recent version has started. This will ensure continued support for the applications.

Except for an outstanding issue with the reporting database this is now complete. The outstanding issue has not yet been resolved and an external agency has been engaged to support us through the issue.

Strategic objective 2 – "To apply information technology within the organisation where it can create business advantage."

• Fitness to Practise (FTP) Case management system project :This project provides status reports to the FTP Committee. The design is now complete and costs are being confirmed for the implementation phase. The project is running to plan and to expectation.

The Document and Records Management system (DRM) has been installed along with the new scanning solution. The Case Management system is currently in development.

• Education service: We have engaged with an external development company to deliver a series of small changes to the Education system.

There has been a delay in this project following faults being identified within user acceptance testing cycles. The expectation is that the service will be released by the end of the fiscal year.

• **Desktop applications upgrade**: Prepare for the upgrade of the desktop operating system by auditing and replacing applications that are not certified with Windows 7.

A super-user group has been formed and has received the new software to test. The super users have received specific bespoke training to give them a more comprehensive understanding of the new products and to allow them to become the first reference point for questions within each department.

The implementation timetable has been published along with training schedules. The feedback from the super-users is positive.

Strategic objective 3 – "To protect the data and services of HPC from malicious damage and unexpected events."

• Network encryption project: The new encryption product has been purchased and installed. The tool allows very granular control by user and by personal computer, called Port Control. It can be used to determine who is able to write data to removable media and whether it is required to be encrypted.

The Fitness to Practise (FtP) team will be the pilot group for

this new functionality. A meeting has been arranged to agree the timetable for implementation with FtP.

• **Credit-card handling:** Support the project to outsource credit card handling to reduce organisation risk of fraud.

PCI DSS (Payment Card Industry Data Security Standards) expert advice has been sort to identify potential solutions and industry best practice for handling credit-card payments by telephone.

A number of technical issues have been identified which the project team are working through. It is expected that the implementation date will be delayed by at least two weeks but the issues appear resolvable.

• **Remote access security**: This project aims to improve the security provision for employees and external support organisations when they connect to the HPC services remotely.

The software has been installed and is being tested by the IT team. The service will be rolled out in a phased approach by individual laptop user.

This is expected to be completed by the end of March.

• **Penetration testing:** Conduct quarterly independent penetration tests of our environment to assure adequate security controls.

The vulnerabilities identified by the last penetration test in July have been addressed with the final change being planned for release to the website in early October. the web release has been delayed and we are waiting on a successful testing cycle before deploying to the live environment. Following the web release a penetration test will be conducted.

Service availability

Online renewals and online register outage: On Tuesday 8 February there was a failure of one of the three application servers used to provide the online renewal and online register services.

The online renewals and register applications were unavailable between 03:00 and 08:30.

The external service provider that hosts these servers misunderstood the set of instructions that they should follow in the event of a server failure. The action they took caused the outage of the service; if they had taken no action the service capacity would have been reduced but the service would have remained available.

The instructions that they follow have now been clarified.

1. Recruitment

All occupational therapy and hearing aid dispenser visitor vacancies were filled in the recent recruitment campaign.

Shortlisting is currently in progress for visitor practitioner psychologists (counselling and occupational) and visitor arts therapists.

Shortlisting is also in progress for panel members prosthetist/orthotist and operating department practitioners and registration assessor practitioner psychologists (counselling, educational and health).

Interviews for the above roles are scheduled for the week commencing 21 March 2011.

Ten appointable lay panel members who were interviewed in October 2010 were contacted and offered appointments due to the projected increase in hearings in 2011 - 2012 and beyond. All ten individuals accepted and will be trained in May 2011.

2. Training

There was no training scheduled for February and March 2011. The team is currently scheduling refresher training for all eligible partners for 2011 - 2012.

3. Partner resignations

One chiropodist/podiatrist visitor and one CPD assessor resigned in January 2011. One prosthetist/orthotist visitor resigned in February 2011.

4. Partner appraisals

Partner appraisals have been scheduled for March. Twenty-five visitors will be appraised across three annual monitoring days and the visit schedule. Seven panel member appraisals have been scheduled and seven pairs of registration assessors.

Feedback from appraisals undertaken in February is being collated and distributed to appraisees.

The panel member and panel chair self assessment forms have been distributed to the remaining 43 partners whose agreements are up for renewal.

5. Team information

The partner team has also been working on recruitment and training plans for 2011 - 2012.

3. Closed consultations

Generic standards of proficiency

The consultation closed on 20 October 2010 on draft revised generic standards of proficiency. The Council is due to consider a paper about the responses to this consultation at this meeting.

Post-registration qualifications

The consultation closed on 1 February 2011. We received 95 responses to the consultation.

The responses are being analysed and will be considered by the Education and Training Committee in the first instance at its meeting in June 2011.

4. Professional Liaison Groups

Social workers (England only)

The last meeting of the PLG will take place on 11 April 2011. The draft standards for consultation are due to be considered by the Education and Training Committee and the Council at their June and July 2011 meetings.

5. Independent prescribing

A request has been received from the DH AHP Prescribing Board that the HPC might own the curriculum framework which is currently being developed to cover supplementary prescribing for radiographers, podiatrists and physiotherapists

and the planned extension of independent prescribing to physiotherapists and podiatrists. The Education and Training Committee will be considering the request at its meeting in March 2011 and this may be subsequently considered by the Council.

6. Guidance on health and character

The Rules to remove the health reference will 'go live' from 1 April 2011. The self-referral process has also recently been amended and streamlined. As result, the guidance on health and character has been updated. This is due to be considered by the Council at this meeting with a consultation being held April to July 2011. It is anticipated that the guidance will be published in late 2011 or early 2012.

7. Consultation on reviewing the mutual recognition directives

The European Union is currently seeking views from competent authorities on potential changes to the Directives which govern mutual recognition of EEA nationals. The Department is currently collating a response to the consultation, working closely with colleagues in the Communications and Registrations Departments.

8. Student registration

The Health and Social Care Bill 2011 if passed into law would allow the regulators to set up voluntary registers of students, subject to impact assessment and a consultation. The GSCC currently maintains a voluntary register of student social workers. At this meeting, Council will be asked to agree a process to make a formal decision about this topic. This will include an impact assessment followed by a consultation to run alongside the other consultations on standards and rule changes related to the social workers project, with a final decision being reached in February 2012.

9. CHRE performance review 2010 - 2011

The Executive has provided further information to the CHRE in response to a range of questions from the CHRE's first assessment. The Executive has subsequently met with the CHRE as part of the performance review process; a final report is anticipated in late June or July 2011.

1. Operational performance

a) Telephone calls

i) UK telephone calls: During the period from 1 January 2011 to 28 February 2011 the team answered a total of 9,457 telephone calls which is 666 more than the same period two years ago.

ii) International telephone calls: During the period from 1 January 2011 to 28 February 2011 the team answered a total of 2,453 telephone calls, which is 25 less than the same period last year.

b) Application processing

i) UK applications: A total of 994 new applications were received during this period and 1,023 individuals were registered, which is 190 more than the same period last year. Applications were processed within our service standard of ten working days of receipt.

Applications for readmission were processed within our service standard of ten working days of receipt.

ii) International applications: A total of 380 new international applications were received in this period and 379 individuals were registered which is 231 more than the same period last year.

iii) Grandparenting applications: A total of six new grandparenting applications were received in this period and 24 individuals were registered which is one less than the same period last year.

1. Council reappointment process

The decision on reappointments rests with the Appointments Commission, acting on behalf of the Privy Council, and their Health and Social Care Appointments Committee will consider the reappointment of members at their meeting in March.

Feedback April 2009 to March 2011









Status of UK applications at end of each month April 2009 - March 2011




Number of registrants with supplementary prescribing rights 2009-11




