However, this was on the basis of all parties responding within the timeframes and no delaying tactics being adopted. A suggestion was made that Council receive a presentation on the process. Council members were keen to emphasise the importance of dealing with cases as quickly as possible in the interests of public protection; 	Director of Fitness to Practise	A paper on the Council agenda for 20 October 2011 ('Modern and efficient Fitness to Practise adjudication') provided more detail on the process. Director of Policy and Standards	Completed. HPC consulted on student fitness to practise and registration from 1 November 2011 to 2 March 2012. On 10 May 2012, the Council reviewed the responses to the consultation. The Council agreed that there would not be a student register for the professions it currently regulates. The Council also agreed that in the long term the fitness to practise of social work students is best managed by the education providers in accordance with the HPC's standards for education and training. However, the Council acknowledged this would place new requirements on social work education providers in England and agreed to consider transitional arrangements to effect this change.
