#### **Events**

**Exhibitions**: We exhibited at Community Care both Live on 21-22 May and Supporting Managers on 18 June. Both events are aimed at social work professionals. At the May event we had over 260 visits to our stand where we were able to provide delegates with information on cpd and registration renewal.

**Meet the HCPC events**: Both our Peterborough events on 3 June were fully booked. We focused on professionalism with discussions centring on how and where professionalism is taught and how professionals should adapt to the situation they are in. More than 50% of the audience were social workers and the types of questions that were asked included registration fees, protected titles and cpd.

**Employer events**: We ran events in Swansea on 28 May and Birmingham on 11 June updating employers on registration, CPD and the FTP process. The feedback from both events is positive with one delegate saying "I have been to a number of events over the years but consider this to be the best in terms of value to me as a manager and looking at issues such as FTP and when to contact HCPC. Well done!"

**Education seminars**: Invitations have been sent to all education providers for the eight seminars planned in the autumn. So far, response has been good with the London event fully booked.

**CPD webinar**: 280 registrants watched our first two CPD webinars on 5 June. The aim of the event was to give registrants information on CPD and the audit process. We had some technical issues in the first session, but these were resolved for

the second session. Feedback has been really good with registrants valuing the fact they could engage with us, without the need to travel or take a lot of time out of work. We are planning two more webinars in September.

**Talks and presentations**: We have given 12 cpd talks in May and June, mostly to local authorities and social workers.

#### Media

**FtP media coverage**: This continues to dominate our coverage and in this period (May) we received a large volume of press relating to the suspension of a paramedic who had written offensive comments on Facebook about a Stafford Hospital.

**Media responses and monitoring**: In May we issued a comment and sent letters to the Editors of The Independent (published), The Times, The Mail Online and The Daily Telegraph in response to BBC's Panorama expose of the appalling treatment of vulnerable individuals in our care homes. Our comment on negative registers was also included in the Sunday Express' 'Care home crusade', as well as supportive comments from then Health Select Committee chairman Stephen Dorrell.

We issued a response to the BBC on the London Ambulance Service whistleblowing story which made allegations about Paramedics cheating in exams during 2009 – 2012.

We provided a quote to Community Care and published a comment on the accountability hearing report which was published by the House of Commons Health Select Committee in June.

## Communications - management commentary

**Professional press**: We are working with Professional Social Work, Community Care and Sanctuary magazine to talk to social workers in England about renewals and CPD.

#### Campaigns

**Tax relief campaign**: The campaign launched in May and had good response on social media, with wide coverage on Twitter in particular, and has been covered in some professional journals / websites. We will shortly begin the second phase of the campaign to include the flyers in certificate mailings to all registrants following renewal / application to the Register.

### Publishing

**Education annual report 2013**: The report was published on 13 May alongside Education Update. The report provides an overview and analysis of the key trends in our approval and monitoring processes during the 2012–13 academic year.

**Professional indemnity and your registration:** We have produced a pdf version of the guidance which will be uploaded to our website on 17 July, when the legislation is passed.

Standards of proficiency – Operating department practitioners: We published the updated Standards of proficiency for operating department practitioners on 2 June.

**HCPC In Focus**: The June edition included information on the upcoming recruitment to Council, the review of the standards of conduct, performance and ethics, the consultation on the

standards of proficiency for biomedical scientists and clinical scientists and our usual round up of HCPC events.

#### Parliamentary

**Parliamentary monitoring**: Baroness Cumberlege led a House of Lords debate on elderly abuse, where, having spoken with Anna van der Gaag, she spoke in support of the HCPC's proposals for a negative register for adult social care workers. In a separate debate, Peers also debated the exclusion of the Law Commissions Bill from the Queen's Speech, possible Section 60s and the regulation of adult social care workers.

Following the debates we wrote to a number of Lords who raised the issue of elderly abuse about our proposals for a negative register for adult social care workers. We also wrote to Geraint Davies MP regarding the regulation of counsellors and psychotherapists, on the back of an intervention he made in the House of Commons debate following the Queen's Speech.

#### Stakeholders

**Meetings**: We have met with fellow regulators and representatives from the Department of Health and Department for Business Innovation and Skills at the latest AURE meeting to discuss ongoing developments of the recognition of professional qualifications directive and other EU issues.

We are also represented on the ADASS Workforce Development Group which met in this period and were one of a number of stakeholders who contributed to a revised set of Standards for

employers of social workers, which have now been republished by the Local Government Association.

**Stakeholder contacts**: We have begun putting together a database of stakeholder contacts at professional bodies, charities and in the devolved administrations, to contact about upcoming council recruitment.

**Northern Ireland Parliamentary event**: We took part in the first ever Northern Ireland joint regulators' Parliamentary event at Stormont. The reception was attended by a number of MLAs as well as representatives from the Department of Health, Social Services and Public Safety and other health and social care groups and patient bodies.

**UK Clinical Ethics Network Conference**: We spoke on the appropriate use of social media by registrants at this international conference on Guernsey, alongside the General Medical Council and the Royal College of Nursing. Whilst on the island we also spoke to a group of 75 registrants on our continuing professional development requirements and the cpd audit process.

#### Web, digital and social media

**Film**: We created a video to promote the publication of the Educational Report, which provides a brief overview of the year's activities. We have also edited and uploaded a series of short films about our cpd standards and audit process as well as the cpd webinar held in June.

**Apps**: We have updated the original HCPC app, both with necessary changes for recent Android and IOS operating

software revisions, and also branding changes in preparation for additional apps. The new registrant app 'My HCPC' has had a soft-launch onto app stores ahead of promotion in July.

**Web requests**: We had 57 requests including intranet content updates, requests for website content to be removed and issues with the android version of our app.

**HCPC blog**: On 2 May we published 'Abuse and older people: more personal accountability required' (Anna van der Gaag)

#### Internal communications

**HCPC Update:** The April and May issues of HCPC Update included articles on the all-employee training away day, the Tidy desk policy, the CSR Charity of the year winner and employee achievements, such as the FtP members who completed the Three peaks challenge.

**All employee awayday:** The all employee training away day took place at Wimbledon Studios on 16 May. The purpose of the day was to allow colleagues to gain a greater understanding of the work of other departments.

All employee meetings: Held on 11 June, Marc gave an organisation update and Michael Guthrie briefed on professional indemnity.


**Communications toolkit**: The first training session for the managers' communications toolkit and team brief was held in May. The second session will take place in late June.
