Items for discussion/approval

Item 7.15/222 Consultation on revised Guidance on conduct and ethics for students (report ref:-HCPC140/15)

- 7.1 The Council received a report from the Executive.
- 7.2 The Council noted the revised standards of conduct, performance and ethics (SCPE) is due to be published in early 2016. Given the changes to the revised SCPE, it has been necessary to revisit the guidance on conduct and ethics for students, whose structure is very closely linked to the standards. Subject to approval from the Council, it is intended to publicly consult on the draft revised guidance for 15 weeks from mid October 2015 to late January 2016.

- 7.3 The suggestion was made that it was important that the guidance included the expectation that students should tell someone if for any reason they were uncertain or unsure about something. In discussion, it was considered that this may be already adequately covered in the consultation document however, this would be reviewed in light of the consultation responses.
- 7.4 The Council approved the consultation paper and draft revised guidance, subject to formal legal scrutiny and minor editing amendments.

Item 8.15/223 Consultation on draft standards for use of exemptions by orthoptists to sell, supply and administer medicines (report ref:-HCPC141/15)

- 8.1 The Council received a report from the Chief Executive.
- 8.2 The Council noted NHS England, alongside the devolved administrations, had proposed amendments to legislation to enable orthoptists who are appropriately trained to use exemptions to sell, supply and administer medicines. If these proposals are accepted, the HCPC would set standards for the use of exemptions by orthoptists; annotate the Register entries of orthoptists who are qualified to use the exemptions; and approve post-registration programmes delivering relevant training.
- 8.3 It was noted that there had been a delay in issuing the consultation on the standards since the Department of Health requested that we did not commence a consultation on the standards until there had been ministerial commitment to proceed with legislative changes. The Council were keen to stress that the shorter consultation period was as a result of this ministerial delay but that the consultation would run for at least eight weeks.
- 8.4 The Council:-
 - (i) approved the consultation paper and draft standards, subject to legal scrutiny and minor editing amendments; and
 - (ii) agreed to a shorter consultation period of 8 weeks.

- 9.2 The Council noted the Secretariat department had advertised for the post of one registrant member for a term starting on 1 January 2016.
