1 Communications projects and activities

Web Project: We have started the initiation phase of the project to review and replace our website platform. Work so far has included detailed planning, a top-level project plan, composition of the project team and understanding supplier and procurement needs. A programme of meetings with key internal stakeholders is also taking place to discuss the project and required departmental resources.

2 Communications expertise to departments

Revised Standards of conduct, performance and ethics (SCPE) (Policy): We held our third #my_standards tweetchat on the evening of Tuesday 21 June. The focus for discussion was Standard 7: reporting and escalating concerns with Policy and Standards Director, Michael Guthrie and Council Member, Robert Templeton. In preparation, we promoted the chat via our social media channels and created an event listing on the HCPC website which featured questions for participants to think about. We have also published a new blog article which discusses the importance of raising and escalating concerns and supporting others to do the same.

Consultations (Policy): We promoted the following consultations: the revised standards of proficiency for social workers in England, renaming the 'local anaesthetics' and 'prescription only medicines' annotations for chiropodists / podiatrists and the consultation on draft standards for the use of exemptions by orthoptists to sell, supply and administer medicines.

3 Business as usual communications activities

Events

Meet the HCPC events: On 25 May we held a Meet the HCPC event in Jersey. 51 registrants attended. Of those who completed the feedback survey, 30% rated the event as excellent and 57% as good. The event was held in conjunction with the signing of the MoU with the States of Jersey's Health and Social Services Department. On 7 June we held a Meet the HCPC event in Belfast. 59 registrants attended. Of those who completed the feedback survey 57% rated the event as excellent and 43% as good.

Exhibitions: On 18-19 May we attended Primary Care and Public Health Live in Birmingham, an event for health care professionals working in primary and community care, public, prison and global health. Over the two days, we engaged with 411 visitors at our exhibition stand and over 400 delegates attended our session on the standards of CPD.

Media

Statements and reactive lines: We provided a statement to Community Care in relation to a social worker being reported to us following a Channel 4 Dispatches documentary.

Articles: As well as our regular column in Complete Nutrition we provided information to Community Care for an article about fitness to practise referrals and on our Education Annual Report. We also successfully amended two articles that appeared on the Community Care website on registrants' human rights being breached and one on the standards of proficiency for social workers. These were inaccurate.

Publishing

On Friday 10 June 2016 we published the revised Guidance on conduct and ethics for students.

Work continues on the service user guide to the Standards of conduct, performance and ethics, currently titled: What to expect from your health and care professional. Following initial online research with service users, which explored what they would expect from such a guide, Community Research will run a service user focus group to review the first draft. We anticipate publication in October 2016.

Following on from an internal review of the house style and visual identity documents, we are currently writing a report, which will be presented to EMT, suggesting areas that need updating and guidance that needs to be added, to ensure both documents remain up to date and as relevant as possible. Once signed off, the guides will be updated, the changes will be disseminated across the organisation.

Stakeholder

Parliamentary monitoring and engagement: Since the last Council update, the Government set out its legislative agenda for the coming year in the Queen's Speech which included the Children and Social Work Bill [HL]. We will continue to monitor the progress of the Bill. A more detailed update on this legislation has been included in the Chief Executive's report to Council.

Parliamentary questions have been on issues such as the numbers of paramedics employed by the London Ambulance Service in the past five years, as well as steps taken to improve recruitment and retention. These came as a result of the recent international campaign to recruit additional paramedics over concerns about staffing.

In the House of Lords, Lord Hunt of Kings Heath introduced a Private Members Bill seeking to utilise the work of the Law Commissions on the reform of regulation of health and social care professionals. We will continue to monitor the progress of the Bill. The same Bill only made it to the First Reading in the 2015 –16 parliamentary session.

Following the elections on Thursday 5 May 2016, Michelle O'Neill MLA was appointed as the new Minister for Health in the Northern Ireland Executive. The Sinn Féin member for Mid Ulster will replace Simon Hamilton in post. A welcome letter with an invitation to meet and discuss the work of the HCPC was sent via Secretariat.

Also new in post is the Health and Sport Committee in the Scottish Parliament. Members will be invited to the stakeholder reception we are planning in October.

Stakeholder engagement activities: On Wednesday 25 May we signed a Memorandum of Understanding (MOU) with the States of Jersey's Health and Social Services Department. We also met with representatives from the Department and ran Meet the HCPC events.

We attended NHS Scotland with an exhibition stand. Whilst in Glasgow we met with Carers Scotland, as part of our ongoing programme of engagement with service user and carer representative organisations. We also attended the Northern Ireland Confederation Annual Conference and Exhibition (Tuesday 28 and Wednesday 29 June 2016).

Also during this period, the Stakeholder Communications Manager attended the ADASS Workforce Development Meeting (Friday 27 May 2016), where he provided an update on HCPC's work in relation to the Children and Social Work Bill. He also spoke at Sports Rehab Expo at Excel (Thursday 16 June 2016) and attended Health + Care, also at Excel (Thursday 30 June) and will be attending the Patient Safety Congress in Manchester (5 and 6 July).

Web and digital

Web deployment: User acceptance testing is being carried out for the latest deployment. Updates include calendar functionality changes to allow separation of fitness to practise hearings from main calendar of events, design improvements to mobile-friendly web pages and admin changes.

Web and digital requests: 90 requests were received including video/graphical content for the all employee awayday, and continued work on voice recording/editing for the IT service desk system.

Apps: Deployment of technical solution to enable latest release of the myHCPC app. This update will add personalisation and improvements to navigation and look and feel.

Internal communications

Employee survey: The results of the Employee Engagement Survey 2016 have been published on the intranet alongside an article and a line manager briefing to support discussion at team and department meetings. Focus groups will also be held to gain further insight into the results and to help inform our action planning.




