## Speaking Up

The NHS National Guardian for 'Speaking Up' is moving on, after 5 years in the role. The national guardian role was set up after it was recommended by Sir Robert Francis' report into whistleblowing in the NHS in 2015 and there are now more than 700 Freedom to Speak Up Guardians across more than 400 healthcare organisations. More than 50,000 cases have been raised to Freedom to Speak Up Guardians since they were established, with numbers of referrals increasing every year.

I was able to connect Dr. Hughes with the wider organisation, building on links established by Kellie Green. Dr. Hughes wrote,

"It has been such a pleasure and privilege working with you and I have learned so much. It's only been possible to make progress with Freedom to Speak Up by having the support of wonderful people like you! I feel really confident that the future is very positive and that Freedom to Speak Up is hardwired into the NHS system and beyond."

We will return to this topic as part of the People strategy discussion at a Council workshop in July.

#### Reflective Reviews

Annual reviews with each Council Member and myself have been scheduled. I have found these immensely valuable in building understanding and relationships, and agreeing the key ways in which we can further enhance Council skills and connections with stakeholders in particular.

# 6. Strategy and Policy

#### 6.1. Strategy

'Benefits realisation' is regularly featured in my discussions whether in FtP, or discussions about the wider organisation with the CEO. I was encouraged by the positive way in which PWC described the engagement of FtP executives in the Perform Plus programme; and the potential transferability of this learning to other areas of the organisation.

## 6.2. Proposed Fee Increase

As Council knows, the proposed fee increase is becoming actual and we are considering how best to make the case for future fee rises, with careful consideration for the impact on registrants, and how we can use incoming funds to strengthen patient safety and support registered professionals.

#### 6.3. Finance

A proposed substantive budget and cost efficiency plan have been prepared for Council's consideration, though these will be subject to further input and refinement, due to a number of variables that need to be quantified.
