## Item 1.07/1 APPOINTMENT OF PANEL CHAIRMAN

- 1.1 The Panel agreed that Mr Mount should act as Chairman for the meeting.
- 1.2 The Panel noted that the Education and Training Committee had agreed that each Panel meeting should elect a Chairman for that meeting.

#### Item 3.07/3 APPROVAL OF AGENDA

3.1 The Panel approved the agenda.

# Item 4.07/4 MINUTES OF THE APPROVALS PANEL HELD ON 5 DECEMBER 2006

- 4.1 It was agreed that the minutes of the eleventh meeting of the Approvals Panel should be confirmed as a true record and signed by the Chairman.
- 4.2 The Panel noted that the unconfirmed minutes of each Panel meeting were circulated electronically to all members of the Panel for approval.

# Item 5.07/5 MATTERS ARISING

- 5.1 The Panel received a paper to note from the Executive.
- 5.2 The Panel noted that the action points arising from the eleventh meeting of the Approvals Panel had been addressed.

## Item 6.07/6 VISITORS' REPORTS

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel noted that the HPC's visits were sometimes conducted at the same time as internal validation or revalidation events organised by the education provider. In those circumstances, the Visitors' Reports would refer to "Joint Panel members", meaning members of the education provider's panel.
- 6.3 The Panel noted that Visitors would usually meet students of the programme which was subject to approval, or students on a similar existing programme.
- 6.4 The Panel noted that the visit to the BSc (Hons) Nutrition and Dietetics programme at the Robert Gordon University had been to evaluate a major change to an existing programme. The change did not relate to placement provision and therefore the visit had not included a meeting with placement providers and educators.
- 6.5 The Panel noted that the Executive would consider how to improve the layout of Visitors' reports.

# Item 7.07/7 VISITORS' REPORTS WITH REPRESENTATIONS

- 7.1 The Panel received a paper for discussion/approval from the Executive.
- 7.2 The Panel noted that the paper included Visitors' reports on three programmes at the University of Wales Institute, Cardiff: BSc (Hons) Human Nutrition and Dietetics; PG Dip Dietetics and MSc Dietetics. The education provider had made representations about a condition in the reports that there should be common assessment tools used in relation to student performance on practice placements.
- 7.3 The Panel noted that the education provider felt that it would be impossible to impose standardisation of assessment tools to be used throughout all placements and also felt that standardised tools would not guarantee standard assessment. The education provider felt that the condition would be very difficult to achieve and a longer term recommendation would be more acceptable.
- 7.4 The Panel agreed that the condition went beyond the scope of Standard of Education and Training (SET) 5.7.4 and felt that it should be removed from the reports. However, the Panel agreed that the Executive should check the Visitors' rationale for the condition as the Panel felt the reason given in the report was unclear and somewhat limited. The Panel agreed that the Executive should ask the Visitors to confirm whether all current assessment tools ensured that students met the Standards of Proficiency. If the Visitors confirmed this, then the Executive should write to the education provider explaining that the condition had been removed. However, if the Visitors could not confirm this, the Visitors' response should be considered by a future Panel meeting.

# Action: AC (by 28 March 2007)

7.5 The Panel noted that the Visitors had considered resourcing for the programmes but this was not entirely clear in the reports. The Panel felt that it would be helpful if Visitors' reports in general could give more detailed reasons for conditions and recommendations. The Panel noted that, where time permitted, the Executive drafted reports which included more detailed reasons and the drafts were checked by the Visitors.

# Item 8.07/8 PROGRAMME APPROVAL

- 8.1 The Panel received a paper for discussion/approval from the Executive.
- 8.2 The Panel agreed that the following programmes should be approved, as the Visitors were satisfied that the conditions in the Visitors' reports had been met and the programmes therefore met the SETs:

#### Item 12.07/12 MAJOR/MINOR CHANGES: 3

- 12.1 The Panel received a paper for discussion/approval from the Executive.
- 12.2 The Panel noted that the University of Derby had submitted a major/minor change submission regarding the relocation of its site of delivery for several programmes: BSc (Hons) Occupational Therapy; BSc (Hons) Diagnostic Radiography; MA Art Therapy; MA Dramatherapy; MA Music Therapy. The Panel noted that all of the programmes, except the Music Therapy programme, had been approved. The relocation was planned to take effect from September 2007.
- 12.3 The Panel noted that the Executive had decided to assess the new site as part of a planned approvals visit to the Art Therapy and Dramatherapy programmes in February 2007. The major/minor change submission had been sent to four Visitors from the Occupational Therapy and Radiography parts of the Register for consideration by correspondence.
- 12.4 The Panel noted that the Visitors assessing the Occupational Therapy programme had recommended that the relocation was a major change and an approvals visit was required to consider the impact on the SETs. However, the Visitors assessing the Diagnostic Radiography programme had recommended that the relocation was a minor change and the programme continued to meet the SETs.
- 12.5 The Panel noted that the Executive felt that the process for considering major and minor changes needed to be reviewed. The process listed criteria for assessing whether a change was major or minor, but the list did not

include all possible changes and the process did not give guidance on when a visit was necessary. The Panel noted that the review was expected to take place in the next financial year.

- 12.6 The Panel agreed that there were difficulties in assessing the physical location of a programme, since only documentary evidence could be provided during construction of new facilities and a visit could only take place once facilities were fully completed.
- 12.7 The Panel agreed that the Executive should notify the Visitors of the conflicting decisions and ask them to provide more information on the reasons for their recommendation, to help decide whether a visit was required. Once this information had been received, the issue should be considered by a future Panel meeting.
