## Item 4.07/18 MINUTES OF THE EDUCATION AND TRAINING PANEL HELD ON 1 FEBRUARY 2007

4.1 It was agreed that the minutes of the first meeting of the Education and Training Panel should be confirmed as a true record and signed by the Chairman.

- 5.1 The Panel received a paper to note from the Executive.
- 5.2 The Panel noted that action points one to four arising from the previous meeting had been addressed.

# Item 6.07/20 VISITORS' REPORTS

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel noted that the Visitors' report for the Diploma of Higher Education in Operating Department Practice at Anglia Ruskin University had set a condition against Standard of Education and Training (SET) 3.7. The condition provided that the education provider should confirm new clinical teaching facilities being constructed at the Chelmsford site were in operation before the new programme commenced, or provide evidence that adequate transitional measures were in place should the facilities be delayed. The Panel noted that the reason given was that students should have ongoing access to facilities.
- 6.3 The Panel noted that the Visitors' report for the BSc programme at the University of Essex had set a condition that the programme team should revisit and resubmit the programme documentation, to remove the word "clinical" from the programme title. The reason given was that clinical science was another profession regulated by the HPC and there was some concern that an applicant might not understand that the programme would entitle a graduate to register as a biomedical scientist.

- 9.4 The Panel noted that a reply had been received from the education provider on 26 January 2007. The letter indicated that the programme leader was the main tutor for the programme and there had been no reduction in her contact time with staff or students.
- 9.5 The Panel agreed that, in the light of the written confirmation, it should accept the Visitors' report as approved by the Approvals Panel on 10 October 2006 and not vary the conditions.
