Three minor changes are proposed as follows:

1. Re-scheduling of units in the first and second years of the programme (to enhance the student learning experience and prevent bunching of assessments.

2. To increase tutorial group sizes from 12-14 to 24-28, with two staff in classroom where the tutorials had previously been delivered in a smaller session, (to facilitate the learning experience associated with PBL, to provide a more diverse student mix, and to facilitate staff development through team teaching).

It is anticipated that actual groups would be no greater than 21 in 2007/2008

3. To reduce the EBP units from five to four weeks duration, to permit the students to graduate in time to be able to attend the summer graduation ceremony after the completion of their final clinical placement.

The proposals have passed through all of the formal quality assurance mechanisms of the University and have the documented support of students and of the external examiner to the course.

There is a proposed change in the system of utilisation of staff for tutorial sessions, from groups of 12-14 with one member of staff, to groups of a maximum of 24-28 with two members of staff.

Hence although the mode of delivery will change, the staff-student ratio in classrooms will remain constant at 1:14.

This is well in line with resourcing for small group sessions in other recognised courses in the United Kingdom.
