Item 1.07/85 APPOINTMENT OF PANEL CHAIRMAN

1.1 The Panel agreed that Ms Thornton should act as Chairman for the meeting.

Item 2.07/86 APOLOGIES FOR ABSENCE

2.1 There were no apologies for absence.

Item 3.07/87 APPROVAL OF AGENDA

3.1 The Panel approved the agenda, subject to considering a paper on MA Music Therapy at Nordoff Robbins Music Therapy Centre as an item of any other business.

Item 4.07/88 MINUTES OF THE EDUCATION AND TRAINING PANEL HELD ON 5 JULY 2007

4.1 It was agreed that the minutes of the fifth meeting of the Education and Training Panel should be confirmed as a true record and signed by the Chairman.

Item 5.07/89 MATTERS ARISING

- 5.1 The Panel received a paper to note from the Executive.
- 5.2 The Panel noted that the action points arising from the previous meeting had been addressed.
- 5.3 The Panel noted that at its previous meeting it had discussed the placement handbook for the BSc (Hons) Physiotherapy programme at the University of Birmingham. The Visitors' report had required an amendment to the handbook, to delete a statement that a minimum of 1000 hours of supervised placement practice was required needed to qualify for registration with HPC. The Panel noted that it was likely that this requirement had arisen from a professional body and confirmed that the HPC had no requirements for the number of placement hours.
- 5.4 The Panel noted that at its previous meeting it had discussed the report on BSc (Hons) Physiotherapy programme at London Southbank University. The report had required the removal of an age restriction, preventing students under the age of 18 from entering the programme. The Panel agreed that the Executive should prepare a paper for the Education and Training Committee on the effect of age discrimination legislation on education programmes and any age requirements imposed by other healthcare regulators.

Item 6.07/90 VISITORS' REPORTS

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel discussed the report on BSc (Hons) Applied Biomedical Science at Anglia Ruskin University. The Panel noted that the report included a condition that the University should provide evidence that the additional 1.5 full time equivalent staff had been employed before the programme commenced. The Panel noted that education providers were sometimes reluctant to commit resources to new programmes until it was clear that the programme had been approved.
- 6.3 The Panel noted that the approvals and monitoring annual report for 2006-7 would analyse trends in programme approval. The Panel suggested that trends or issues at individual education providers should be analysed.

- 6.4 The Panel discussed the report on MSc Occupational Therapy (preregistration) at Brunel University. The Panel noted that both Visitors had been from the same university, due to exceptional circumstances. The Panel noted that the Executive usually attempted to find Visitors with different backgrounds.
- 6.5 The Panel noted that the report included a condition that the university should put in place an interview procedure as part of its admission process. The reason given was that interviews with prospective students were currently only held in exceptional circumstances and the Visitors did not believe that this process was sufficiently robust.
- 6.6 The Panel agreed that the condition was beyond the scope of Standard of Education and Training 2.1, which only required that the admission procedures should give the applicant and education provider the information they required to make an informed choice. The Panel agreed that the condition should be amended to refer to putting in place a "robust procedure" for the admission process and that the reason should explain that this was to ensure that the entry criteria were being met consistently.

Action: AC (by 27 September 2007)

- 6.7 The Panel noted that the description of the background of Visitors in the reports was inconsistent (for example, some reports listed the Visitors' profession, whilst others listed their university or their place of work). The Panel noted that members of the Education Department had now been trained in writing reports. It was intended that a new style of Visitors' report would be brought to the meeting of the Education and Training Committee on 27 September 2007 for discussion/approval.
- 6.8 The Panel discussed the report on BSc (Hons) Occupational Therapy at London Southbank University. The Panel noted that the report included a condition that the programme documentation should be revised, to make it clear that completion of the programme only lead to eligibility to apply for HPC registration. The Panel noted that some programmes had prepared their documentation before the guidance on the standards of education and training had been published. It was hoped that the guidance would help education providers to prepare more comprehensive and accurate documentation.
- 6.9 The Panel noted that the report on Non Medical Prescribing at Napier University had imposed a number of conditions about practice placements. The Panel noted that this reflected wider

issues about locating designated medical practitioners to supervise placements on non medical prescribing programmes.

- 6.10 The Panel discussed the report on MA Music Therapy at Nordoff-Robbins Music Therapy Centre (North West). The programme was delivered at the Royal Northern College of Music and validated by City University.
- 6.11 The Panel noted that the report included a condition that the programme team should draft and submit advertising material, to clearly articulate the distinction between the programme and other music therapy programmes available in the UK. The Panel noted that the Visitors had felt that applicants should be made aware of the innovative type of delivery in the programme. The Panel agreed that the condition should be amended to state that the programme team should draft and submit advertising material to clearly articulate the innovative approach of the programme. The Panel agreed that the reference to other music therapy programmes should be deleted.

Action: AC (by 27 September 2007)

- 6.12 The Panel noted that the report included a condition that the programme team should redraft and resubmit the programme documentation, to clearly articulate the types of support available to students from all three institutions. The Panel noted that the Visitors had felt that the documentation provided much information about available support, but in discussion between the Visitors and the programme team it had become apparent that there would be some additional resources available. The Panel noted that the Visitors had felt that the documentation should therefore be clarified.
- 6.13 The Panel noted that the report included a recommendation that Nordoff-Robbins Music Therapy Centre North West and the Royal Northern College of Music should consider extending the minimum tenancy period to ensure that least one cohort would be able to complete the programme at the same venue. The Panel agreed that if there was no guarantee that the first cohort could progress and complete their programme at the same venue, then there was insufficient evidence that the programme had a secure place in the education provider's business plan. To ensure that the standard of education and training 3.1 was met, the Panel agreed that the report should be amended so that this recommendation became a condition of approval. The Panel agreed that the wording of the recommendation should be amended to state that the education provider should provide evidence of a "secure venue" for the programme for at least the first cohort. The Panel agreed that the reason should be amended to clarify the requirements for a longer term commitment to the resources and the need to reduce any

potential risks to the programme's delivery. In addition, the Panel noted that any relocation of delivery site, at a later stage, would constitute a major change.

Action: AC (by 27 September 2007)

- 6.14 The Panel noted that the visit to the BSc (Hons) Dietetics programme at the University of Plymouth had arisen due to the annual monitoring process.
- 6.15 The Panel noted the report on the Postgraduate Certificate Non Medical Prescribing (Level M) and Graduate Certificate Non Medical Prescribing (Level 3) at the University of Salford. The Panel noted that the programmes were intended for several professions, including pharmacists and nurses.
- 6.16 The Panel noted that the reports on the Operating Department Practice programmes included a number of conditions. The Panel noted that it was likely that the programme teams were gaining experience over time at preparing documentation to meet the SETs.
- 6.17 The Panel noted that the report on the Foundation degree in Paramedic Science at the University of Teesside included a number of conditions. The Panel noted that this reflected the programme's move into the higher education sector and the need to develop a number of aspects of the programme, including protected time for students to study and issues around Accreditation of Prior Experiential Learning. The Panel noted that a second visit was proposed to be held in early September to determine whether the conditions had been met.

Item 12.07/96 ANY OTHER BUSINESS

- 12.1 The Panel received a tabled paper for discussion/approval from the Executive.
- 12.2 The Panel noted that at the last meeting, it had discussed a late representation against conditions in the Visitors' report for MA Music Therapy at Nordoff Robbins Music Therapy Centre. The Panel had decided that it wished to seek the professional view of Professor Waller, the Arts Therapist member of the Education and Training Committee, before making a final decision.
- 12.3 The Panel noted that the Visitors' report contained two conditions and that the Visitors had felt that the second condition had been met. The Visitors felt that the first condition had not been met. The outstanding condition required that the provider should make every effort to ensure each student's first period of Personal Music Therapy did not overlap with the start of his or her external Personal Psychotherapy, nor the second session of Personal Music Therapy with the last sessions of Personal Psychotherapy.
- 12.4 The Panel noted that Professor Waller had written to the Education Manager on 25 July 2007. Professor Waller had indicated that she respected the concerns of the Visitors about the outstanding condition. Having considered the philosophy of treatment of the Nordoff-Robbins Music Therapy centres, Professor Waller felt that if there should be an overlap in the students' personal psychotherapy and in their music therapy this would not be damaging to the students. Informed consent from both student and therapists to such an overlap would need to be obtained. The Panel noted that it was possible that other programmes had overlapping therapies.
- 12.5 The Panel agreed that, in the light of Professor Waller's advice, that the first condition should remain in the Visitors' report but that the HPC should now agree that the first condition had been met.
- 12.6 The Panel agreed to accept the Visitors' report and agreed that the following programme should be approved as meeting the SETs:
