We would encourage the programme to submit CVs for any new members of staff together with a statement of hours (if not included in most recent programme document submitted to HPC) with future annual monitoring submissions.

The visitors accept that the year 2006-07 was exceptional in terms of staff absence/illness and this accounts for staff development reports for only two members of staff being included in the internal quality report for that year.

The visitors are satisfied that the programme is doing its best to provide adequate storage for students' artwork, and meets the standard. However, the programme has itself identified this provision as less than ideal, and the visitors would like to support the programme by recommending that this matter be kept under review and improved storage solutions sought.

Further comments

The visitors wish to draw attention to the fact that the staffing difficulties between November 2006 and October 2007 were severe enough to have constituted a major change to the programme and should have been reported to HPC.

In the External Examiner's Report from 2006/07 the External Examiner raised concerns about automatic compensation regulations and the possibility of students progressing through the programme lacking the skills for professional practice, and recommended that a mapping exercise take place against the SOPs to ensure that this is not compromised. In response to this the programme team stated that they would check how well the current modules mapped against the SOPs. As meeting the SOPs is required for approval of the programme the visitors would like to receive this work to ensure that the programme meets this Standard of Education.
