#### Item 1.08/1 Appointment of panel chairman

# Item 4.08/4 Minutes of the Education and Training Panel held on 4 December 2007

4.1 It was noted that the minutes of the tenth meeting of the Education and Training Panel had been confirmed as a true record by the members of that Panel. The minutes would be signed by Ms Farrell, who had chaired that meeting.

### Item 5.08/5 Matters arising

- 5.1 The Panel received a paper to note from the Executive.
- 5.2 The Panel noted that the action points arising from the previous meeting of the Panel had been dealt with.

## Item 6.08/6 Visitors' reports

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel noted that the report on the BSc (Hons) Diagnostic Radiography programme at the Robert Gordon University had recommended that the admissions policy should make more explicit the advantage of including service representation in the selection interview. The Panel noted that placement providers had a role in the selection process for the programme.
- 6.3 The Panel discussed the report on the BSc (Hons) Biomedical Science with DPP (Pathology) at the University of Ulster. The Panel noted that the report included a condition that the student handbook should be redrafted, to include further information about entrepreneurship and the selection criteria and process for allocation of funded places. The Panel noted that all programmes at the education provider included teaching about entrepreneurship and the visitors felt that this was unusual, but not detrimental to the programme. The Panel noted that the Executive and visitors always ensured that the standards of proficiency were not outweighed by other learning outcomes which might be introduced.
- The Panel discussed the reports on physiotherapy and occupational therapy programmes at York St John University. The Panel noted that the reports included a condition for the education provider to provide a list of names of all staff in the programme team and the roles the staff had on the programme. The Panel noted that the programme documentation had been unclear on the roles which staff were undertaking and any other commitments which they had. However, the visitors were now satisfied that the education provider had met the conditions.
