### Item 1.09/48 Apologies for absence

2.1 The Committee approved the agenda, subject to receiving a tabled paper under item 24 (any other business).

### Item 3.09/50 Declarations of members' interests

3.1 Members had no interests to declare in connection with the items on the agenda.

# Item 4.09/51 Notes of strategy meeting held on 25 March 2009 (report ref: ETC 32/09)

- 4.1 The Committee agreed that the notes of the strategy meeting of the Education and Training Committee held on 25 March 2009 should be confirmed as a true record.
- 4.2 The Committee noted that some members felt that a review of Standard of Education and Training 1 should be a priority for the Education and Training Committee.

# Item 5.09/52 Minutes of the Education and Training Committee meeting of 20 May 2009 (report ref: ETC 33/09)

5.1 The Committee agreed that the minutes of the 40th meeting of the Education and Training Committee should be confirmed as a true record and signed by the Chairman.

- 6.1 The Committee received a paper to note from the Executive.
- 6.2 The Committee noted the progress report on the decisions agreed at the last meeting.

- 7.1 The Committee received a verbal report from the Chairman.
- 7.2 The Committee noted that this would be the last meeting of the

Committee before the Council and its committees were restructured. The Chairman thanked members of the Committee and the Executive for their contribution to the Committee's work.

### Item 8.09/55 Director of Education's report (report ref: ETC 35/09)

- 8.1 The Committee received a report on the work of the Education Department.
- 8.2 The Committee noted that approval and monitoring processes for the 2008-9 academic year were in the process of being completed.
- 8.3 The Committee noted that the Department had worked on a number of publications, including the annual report on the 2007-8 academic year. The Executive intended to electronically circulate the draft annual report to members for comment.
- 8.4 The Committee noted that the paper summarised the status of each of the approval visits to the IHCD paramedic awards. There were a number of final decisions still outstanding. Once the majority of these decisions had been made, the Executive would begin analysing trends from the approval process. It was anticipated that an initial report would be made to the meeting of the Committee on 22 September 2009.
- 8.5 The Committee noted that the Department had launched an 'Education Update' newsletter in May 2009, which would be issued to education providers at key times during the year. The Committee noted that feedback had been very positive and additional stakeholders had been added to the distribution list for future issues.
- 8.6 The Committee noted that the paper included an analysis of multiprofessional visits to education providers. The Committee noted that this type of visit was usually requested by the education provider. The Department had processes in place to ensure that all programmes considered at a multi-professional visit were scrutinised equally.
- 8.7 The Committee thanked the Department for its work.

# Item 9.09/56 Practitioner psychologists – Threshold level of qualification for entry to the Register (report ref: ETC 36/09)

- 9.1 The Committee received a paper for discussion/approval from the Executive.
- 9.2 The Committee noted that, at its meeting on 20 May 2009, it had agreed to recommend to the Council that the threshold level of qualification for entry to the practitioner psychologists part of the register should be a masters degree, but that this recommendation should be subject to the development of wording that reflected that further training and experience would also be required to be eligible for the Register. The Council on 20

May 2009 had not reached a final decision about the threshold level and had referred the matter back to the Committee for further consideration.

- 9.3 Mr Bracken advised the Committee that it should set the threshold level of qualification at a level which was necessary to ensure that a student would meet the standards of proficiency and be able to practise safely and effectively. The Committee noted that it could take account of the existing requirements for qualifications which had been developed by the profession but that this should not be the only consideration. The Committee noted that it was likely that issues around the threshold level were likely to arise in other professions which might be regulated by HPC in the future.
- 9.4 The Committee noted that the paper contained additional information which it did not consider during its last discussion on existing entry routes to the domains of practitioner psychology and also British Psychological Society (BPS) stage two qualifications which conferred eligibility to register. The Committee agreed that this information added clarity about the existing provision and how it was argued that this was linked to safe and effective practice.
- 9.5 The Committee revisited the three broad options discussed at its meeting in May 2009, and outlined in the paper at this meeting. The Committee gave further consideration to options 2 and 3. The Committee had regard to the need for any threshold standard to be meaningful and easy to understand and communicate to education providers. The Committee considered that it problematic to formulate wording to support option 3.
- 9.6 The Committee agreed that its recommendations to the Council should allow flexibility and ensure that the recommended threshold level of qualification would be applicable across all four countries of the UK.
- 9.7 In the light of the information in the paper, the standards of proficiency which it had previously agreed and existing provision, the Committee decided to recommend option 2. The Committee therefore agreed to recommend to the Council that the threshold level of qualification should be set as follows for practitioner psychologists:
  - Doctorate for clinical psychologists
  - Doctorate for counselling psychologists, or equivalent
  - Doctorate for educational psychologists, or equivalent
  - Masters degree for forensic psychologists (with the award of the British Psychological Society qualification in forensic psychology, or equivalent)

- Masters degree for health psychologists (with the award of the British Psychological Society qualification in health psychology, or equivalent)

# Item 10.09/57 Practitioner psychologists – List of approved programmes (report ref: ETC 37/09)

- 10.1 The Committee received a paper for discussion/approval from the Executive.
- 10.2 The Committee noted that the paper asked it to approve the list of programmes for practitioner psychologists which would become effective from the date of the register opening (1 July 2009), as well as a list of programmes which had been approved historically for specific periods. The lists were based on the accreditation information available from the BPS. The Committee noted that there might be some revisions to the lists in the light of further information from the BPS. The Committee noted that it would be asked to confirm a revised list of programmes at its meeting in September 2009.
- 10.3 The Committee noted that the paper listed currently approved programmes, historically approved programmes (individual programmes; and combination routes). A combination route had been used by the BPS to assess applicants' prior knowledge and experience in addition to their accredited qualification.
- 10.4 The Committee:
  - granted open ended approval to the programmes outlined in appendix 1 to these minutes (subject to receiving the final data from the BPS and any subsequent editing);
  - approved the programmes for the historical periods outlined in appendix 2 to these minutes (subject to receiving the final data from the BPS and any subsequent editing);
  - confirmed that the programmes outlined in appendix 2 to these minutes were no longer approved (subject to receiving the final data from the BPS and any subsequent editing);
  - approved the combination routes for the historical periods outlined in appendix 3 to these minutes (subject to receiving the final data from the BPS, any subsequent editing and legal advice).
  - confirmed that the combination routes outlined in appendix 3 to these minutes were no longer approved (subject to receiving the

- agreed to publish the appropriate lists of approved programmes; and
- agreed that the above decisions would become effective from the date of the register opening (1 July 2009)

# Item 11.09/58 Practitioner psychologists – approval and monitoring processes (report ref: ETC 38/09)

- 11.1 The Committee received a paper for discussion/approval from the Executive.
- 11.2 The Committee noted that the paper asked it to approve the means by which the approved practitioner psychologist programmes which had been granted open-ended approval would have their ongoing approval reconfirmed by HPC.
- 11.3 The Committee noted that the BPS currently operated a system of accreditation for programmes delivered by higher education institutions. The Committee noted that there were also a number of qualifications which were offered directly by the BPS, which were currently subject to an internal review by the BPS. The Committee noted that it was intended that HPC would arrange its approval visit after the BPS had completed its own review of the BPS's own programmes.
- 11.4 The Committee noted that it was intended that practitioner psychologist programmes would be visited over a period of three academic years (2009-10, 2010-11 and 2011-12). It was intended that all visits would be held by July 2012, with ongoing approval of all programmes reconfirmed by the 2012-13 academic year at the latest. The Committee noted that the current BPS accreditation process was robust and thorough and programmes had been producing students who were fit to practice. There was no evidence to suggest that the visit schedule should be completed within a shorter time-frame. The proposed timetable was reasonable and feasible for education providers without being overly burdensome. It was also realistic and achievable, given HPC's current resources and commitments to the existing 13 professions regulated by HPC.
- 11.5 The Committee noted that one consequence of the proposed visit schedule was that a number of programmes would not be subject to an approval visit for at least two academic years. To mitigate any risks which this might present, the paper recommended that an amended version of the annual monitoring process should be used in the interim.

11.6 The Committee noted that, for programmes subject to currently unconcluded BPS accreditation visits, it was proposed that all of those programmes should be granted open-ended approval on the day that the HPC Register opened. Priority would be given to determine the effect of the outcome of the BPS re-accreditation visit on the programme's ongoing approval with the HPC. The proposed mechanism would be based on visitors assessing the BPS accreditation report and making recommendations to the Committee on relevant future action. Decisions would be made on a case by case basis and be cognisant of the standards of education and training and standards of proficiency.

### 11.7 The Committee:

- approved the mechanism outlined in the paper (summarised at paragraph 11.6 above) for considering the outcome of currently unconcluded BPS accreditation visits (subject to receiving the final data from the BPS and any subsequent editing);
- approved the approval visit schedule outlined in the paper (subject to receiving the final data from the BPS and any subsequent editing);
- approved the annual monitoring requirements outlined in the paper (subject to receiving the final data from the BPS and any subsequent editing);
- agreed that the above decisions become effective from the date of the register opening (1 July 2009);
- agreed that the above decisions should be communicated to education providers;
- asked the Executive to implement the approval visit schedule with a degree of flexibility, ensuring that each visit is confirmed on a case by case basis; and
- asked the Executive to periodically update the Committee on the progress of work in this area.

# Item 12.09/59 Guidance on conduct and ethics for students – Key decisions (report ref: ETC 39/09)

- 12.1 The Committee received a paper for discussion/approval from the Executive.
- 12.2 The Committee noted that a consultation had been held between 30 January 2009 and 30 April 2009 on draft guidance on conduct and ethics for students. There had been a number of very positive responses to the draft guidance and where possible the draft guidance had been amended in the light of responses.

- 12.3 The Committee noted that one response to the consultation had asked whether the term 'service user' included practice educators and staff members. The Committee noted that HPC's use of the term within the standards of conduct, performance and ethics referred to anyone affected by a registrant's work and therefore could be read as including a registrant's colleagues.
- 12.4 The Committee agreed that the consultation responses document should be amended so that the first bullet point in section 12 of the guidance would read 'You should not try to pass off other people's work as your own'.
- 12.5 The Committee:
  - recommended the publication of the consultation responses document on the website, subject to the amendments above; and
  - recommended the text of the consultation responses document and guidance to the Council, subject to the amendments above, minor editing changes and legal scrutiny.

12.6 The Committee noted that a separate consultation had been held on the health and character process. The health and character guidance would be revised in the light of the consultation and brought to the meeting of the Committee in September 2009 for consideration.

# Item 13.09/60 Consultation on the registration cycle for hearing aid dispensers (report ref: ETC 40/09)

- 13.1 The Committee received a paper for discussion/approval from the Executive.
- 13.2 The Committee noted that the Department of Health was currently consulting on an Order under section 60 of the Health Act 1999. Under the proposed Order, the Hearing Aid Council would be abolished and responsibility for registration of hearing aid dispensers would be transferred to HPC.
- 13.3 The Committee noted that, in 2008, HPC had consulted on the registration cycle for hearing aid dispensers, based on the register opening in April 2009. However, the legislation had been delayed and it was now anticipated that that a new part of the Register for hearing aid dispensers would open in April 2010. The delay affected the two year registration cycle and therefore consultation on a revised registration cycle was required.

- recommended to the Council that it should consult on setting the registration cycle for hearing aid dispensers; and
- recommended the text of the consultation document to the Council (subject to minor editing amendments).

# Item 14.09/61 Ronin Protective and Paramedical Services South Africa (report ref: ETC 41/09)

- 14.1 The Committee received a paper for discussion/approval from the Executive.
- 14.2 The Committee noted that the IHCD paramedic award delivered jointly by Ronin Protective and Paramedical Services, South Africa ('Ronin') and South West Ambulance Service NHS Trust (SWAST) had previously been accredited by the IHCD. The Committee noted that HPC had previously agreed that IHCD should be approved as an education provider. However, in March 2008, the Committee had agreed to regard individual sites of delivery as the education provider for IHCD award and the IHCD as the validating body. The Committee had also agreed in March 2008 that it was not possible to approve programmes or franchised and collaborative programmes which were delivered outside of the UK by a non-UK education provider. However, it was possible for a UK education provider to deliver a programme in whole or in part overseas.
- 14.3 The Committee noted that, in February 2009, the Executive had sent a form to Ronin Protective and Paramedical Services to gather information about the programme. Following information provided by Ronin and SWAST and legal advice from HPC's solicitor, the Executive had decided that the paramedic award delivered jointly by Ronin and SWAST should be considered to be a programme or franchised and collaborative programme delivered outside of the UK by a non-UK education provider. Ronin and SWAST had been informed of the decision and had appealed against the decision.
- 14.4 The Committee noted that, separately to these developments, the Health Professions Council of South Africa (HPCSA) had written to HPC expressing concern about the programme. In particular, HPCSA was concerned that the programme required extensive clinical experiential training which was conducted on South African citizens. In addition, people on the HPCSA Intermediate Life Support register were enrolling for the programme and were practising outside their scope of practice. This constituted a transgression of the South African Health Professions Act 1974 and the Ethical Code.
- 14.5 The Committee agreed that:

- the programme was a franchised and collaborative programme delivered outside of the UK by a non-UK education provider. The Committee felt that there was no guarantee that placements took place in the UK. In addition, the Committee agreed that the appeal by SWAST and Ronin had not fully answered the HPC's requests for information;
- the IHCD paramedic award delivered by Ronin and SWAST should not be regarded as an approved programme, to the extent that it had ever been approved by HPC. The Committee agreed that the evidence did not seem to meet the requirements of a UK education provider delivering the programme in whole or in part outside of the UK and therefore could not be considered as an approved programme, in accordance with the Committee's decision in March 2008 mentioned at paragraph 14.2 above;
- the Chief Executive and Registrar should write to the Health Professions Council of South Africa to explain HPC's decision and reasons; and
- the Executive should write to SWAST and Ronin to explain HPC's decision and reasons.

# Item 15.09/62 Isle of Wight NHS Primary Care Trust – IHCD Paramedic Award (report ref: ETC 42/09)

- 15.1 The Committee received a paper for discussion/approval from the Executive.
- 15.2 The Committee noted that, in March 2008, it had agreed that the Executive should undertake a programme of visits to the delivery sites of IHCD paramedic awards across the UK to reconfirm ongoing approval where appropriate. An approval visit had been held at the Isle of Wight NHS Primary Care Trust on 28-29 October 2008.
- 15.3 The Committee noted that the visitors' report had included a large number of conditions which had to be met before ongoing approval of the programme could be confirmed. The education provider and HPC had agreed a deadline of 8 May 2009 to meet the conditions, as there were currently no students on the programme and no cohorts were planned for entry for the future. The risk to the public had therefore been considered to be minimal.
- 15.4 The Committee noted that, prior to the deadline for the response to conditions, the education provider had informed the Executive that a delay might be likely. The education provider had been asked to submit information to explain the delay and this had been provided. The Executive had informed the education provider that, in effect, the first attempt to meet conditions had been exhausted and that a second

attempt remained, although it might be possible to regain the first attempt if there were extenuating circumstances.

- 15.5 The Committee noted that the education provider had responded with a letter dated 29 May 2009 which set out continued delays in meeting conditions. The education provider had indicated that the ambulance service was going through an organisational restructuring and operational work had taken priority over preparation of material for the approval process. The development of the swine flu pandemic had also required work to develop training material to ensure that the education provider was prepared operationally. The ambulance service was also the smallest service in the UK, with significantly less resources and managers undertaking several roles.
- 15.6 The Committee noted that HPC had informed the education provider that the continued inability to meet conditions might lead to a decision from the Committee to commence proceedings for withdrawal of approval.
- 15.7 The Committee agreed to commence proceedings for withdrawal of approval, for the following reasons:
  - the issues around service restructuring and preparations for swine flu pandemic were not unique to the education provider and applied to a number of ambulance services across the UK;
  - it had been eight months since the visit had taken place and it appeared there would be a protracted period before the education provider could begin to address the conditions in the visitors' report;
  - there appeared to be little prospect of the education provider being able to address all of the conditions in the visitors' report.
- 15.8 The Committee agreed that the Trust's chief executive should be informed that the Committee was of the opinion that, based upon the evidence before it, the programme would not meet the standards of education and training and that the Trust should be invited to submit any observations it might wish to make on the reasons set out in paragraph 15.7 above.

15.9 The Committee noted that the education provider would have 28 days to respond and, if provided, any response would need to be considered by the Committee before any decision could be made on whether or not to withdraw approval.

- 16.1 The Committee received a paper for discussion/approval from the Executive.
- 16.2 The Committee noted that the Council on 20 May 2009 had considered its Code of Corporate Governance and its constituent parts. Subject to some minor amendments and approval by the Education and Training Committee of its Scheme of Delegation, the Council had agreed the code with the exception of the composition of committees.

- 17.1 The Committee received a paper for discussion/approval from the Executive.
- 17.2 The Committee noted that the renewal and final renewal forms had previously been reviewed in 2006. The forms had recently been reviewed in preparation for statutory regulation of practitioner psychologists on 1 July 2009. Feedback from stakeholders had also been considered and minor changes had been made to the forms to make them clearer and easier to use.
- 17.3 The Committee recommended that the Council approve changes to the renewal and final renewal forms.

# Item 18.09/65 Withdrawal of approval from historic programmes (report ref: ETC 45/09)

- 18.1 The Committee received a paper for discussion/approval from the Executive.
- 18.2 The Committee noted that the Education Department held a list of approved programmes which were recorded as 'closed'. Those programmes either had no students, or had students but were no longer recruiting additional cohorts. As all of those programmes were still approved, there was a risk that an education provider might re-establish a training programme as leading to eligibility to apply for registration with

HPC. The Committee noted that the programmes had submitted a signed form seeking agreement that their ongoing approval should be withdrawn.

- 18.3 The Committee noted that it would be asked to withdraw approval from a number of other programmes at its meeting on 22 September 2009. The Executive intended to seek withdrawal of approval from programmes on a regular basis in the future.
- 18.4 The Committee agreed that the programmes listed in appendix 4 to these minutes should have their ongoing approval status withdrawn.
