SET 3: Programme management and resource standards

3.1 The programme must have a secure place in the education provider's business plan.

Evidence requested

The visitors need clarification on the future of the current approved BSc (Hons) Paramedic Practice programme and in particular, if the programme is closing down, when the last intake is due to occur. The visitors would also like to see evidence that the programme still has a secure place in the education provider's business plan.

Reason for evidence requested

The visitors noted that the Annual Monitoring for Academic Year 2007 / 2008 Course/Subject Report refers to recruiting to the BSc (Hons) Paramedic Practice degree for the last time. This is due to the local Strategic Health Authority commissioning a diploma programme for which the education provider has been shortlisted. Therefore in light of this information, the visitors need clarification on the future of the current approved BSc (Hons) Paramedic Practice programme.

SET 5: Practice placement standards

5.8.3 Unless other arrangements are agreed, practice placement educators must undertake appropriate practice placement educator training.

Evidence requested

The visitors need clarification regarding the mentorship training provided by the education provider to ensure that all practice placement tutors and mentors have undertaken appropriate mentorship training. If all practice placement tutors and mentors have not completed mentorship training, the visitors need to see evidence of interim arrangements that the education provider has put in place in order to ensure that practice placement tutors and mentors have undertaken appropriate mentorship training.

SET 3: Programme management and resource standards

3.2 The programme must be managed effectively.

Evidence requested

The visitors require further evidence to ensure that programme is managed effectively. In particular, visitors' need to be certain that there are enough practice placements provided for all students on the programme.

Reason for evidence requested

The Annual Programme Report 2006/2007 raised issues about the lack of placements that were available for students. In some instances students had their placements delayed or cancelled, due to problems in finding suitable placements and placement clinical supervisors. The response to the External Examiners report specifically addressed these concerns raised, and in particular, advised the removal of the 'Understanding operational training 2AHP0011' module which contained the assessment that required re-marking.

Although these concerns were appropriately addressed, the External Examiners report identifies issues that the visitors' would like to further explore, regarding the mechanisms employed within the programme to ensure appropriate assessment standards. The visitors' require further evidence, such as an overview the assessment strategy, to be satisfied that there are effective mechanisms in place to assure appropriate standards of assessment for the programme and that the programme continues to meet SET 6.5.
