Withdrawal of approval from historic programmes

Executive summary and recommendations

Introduction

As a result of the completion of the definitive list of approved programmes, the Education Department holds a list of approved programmes that are recorded as "closed". These programmes either have no students, or have students but are no longer recruiting additional cohorts.

As all of these programmes still carry approved status the risk exists that an education provider may re-establish a training programme as leading to eligibility to register with the Health Professions Council.

This paper is asking the Education and Training Committee to agree:

- for appendix one to withdraw ongoing approval from the programmes on the basis that the relevant education provider has provided consent for withdrawal of approval.
- for appendix two to withdraw ongoing approval from the programmes on the basis that following the decision taken by Committee to commence proceedings to withdraw approval notification of this action has been sent to the relevant education provider and they have not provided representations for withdrawal of approval.

All correspondence relating to the provision of consent or not has been checked and confirmed by the executive.

Decision

The Committee is asked to agree the following:

- That the programmes listed in appendix one, which have submitted their consent, have their ongoing approval status withdrawn.
- That the programmes listed in appendix two, which have not submitted any representations following notification of the Committee's intent to withdraw approval, have their ongoing approval status withdrawn.
