Following an annual monitoring audit, an approval visit is required to determine how the programme continues to meet the standards of education and training.
Reasons
<p>The Panel was content that HPC's standard conflict of interest process had been followed as part of the annual monitoring process, and that HPC had deemed the conflicts insignificant.</p> <p>A visit is required to review the issues raised in the annual monitoring visitors' report. Owing to the number and nature of issues highlighted by the visitors, a visit must be undertaken as soon as possible in order to ensure that the programme is compliant with the standards required for safe and effective practice. A visit should be scheduled after a 3 month period or in the programme's first month in its new location if this after 3 months.</p>

Reasons
A visit is required to review the issues raised in the annual monitoring visitors' report. Owing to the number and nature of issues highlighted by the visitors, a visit must be undertaken as soon as possible in order to ensure that the programme is compliant with the standards required for safe and effective practice. A visit should be scheduled for the first semester of the programme, a minimum of six months following the notification period.
