# Standards of Education and Training review meeting: Stakeholder feedback

# Introduction

The Health Professions Order says that we must set our standards to protect the public, and that we must set standards which are necessary for safe and effective practice. This is why our standards are set at a 'threshold' level (the minimum standard that must be met before we can allow entry onto the register).

The Standards of Education and Training (SETs) were published in 2004. They are applicable to education providers and the programmes that they run for professions currently regulated and those which may be regulated in the future.

They have been used by education providers and visitors for 3 years to assess whether a graduate from an educational programme will meet the Standards of Proficiency.

A professional liaison group (PLG) has been set up to review the SETs and examine, discuss and agree to any alterations to the SETs or guidance that the group feel are required. To elicit the views of stakeholders who use, or are affected by, the SETs we sent out emails and questionnaires (see appendices) to targeted stakeholders. We asked the stakeholders to respond using the questionnaires that we provided them with (appendix 2 and 4).

We approached the course leaders of all the programmes we currently approve and requested that they passed the details on to their practice placement providers and relevant student bodies. We also requested responses from other educational organisations such as the Council of Deans and The Higher Education Academy. We also approached all of the visitors who assess the educational programmes against the SETs.

# Feedback

We received 46 responses from the selected stakeholders and we would like to take this opportunity to thank them. Many stated that the SETs were clear, easy to interpret and suggested that no alterations were required to either the SETs or the guidance. Others felt it was necessary to reword some of the SETs and guidance as well as reordering the SETs so that they were more user-friendly.

The following feedback are the main themes highlighted by respondents. The suggested changes to the SETs and guidance are mapped out against the individual SET in document titled 'Issues to consider and suggested changes to the SETs'.

# Main issues

The following is a list of the main issues that have been brought to our attention. This is not a definitive list and other issues may come to light during the discussions of the review group.

- The order of the SETs.
- Wording of specific SETs (additional and alterations). •
- Adding new SETs, combining SETs or rewriting SETs to pull out the differences.
- More detailed guidance on how the standards are audited and clear • indicators of when to fail a student.
- More detailed guidance regarding disability and reasonable adjustments. ٠
- Criminal convictions checks prior to completion of a programme. ٠
- The inclusion of 'where appropriate' in standard 2.2.5 with regard to AP(E)L.
- Staff/student ratios.
- Mandatory inter-professional learning.
- Practice placement mentoring
- Closer and more formal working agreements between education providers and practice placement providers.
- Limitation or guidance on the number of failed assessments allowed •
