Introduction

 The purpose of this paper is to inform the Committee of the Partner team and their activity, provide statistics on Partner numbers and turnover (overall numbers including Panel Members, Panel Chairs and Legal Assessors), provide information on upcoming recruitment and selection activity and provide information on Equality & Diversity Data for Panel Members, Chairs and Legal Assessors.

Partner Team and Activity

- 2. The Partner team is made up of the HR Manager (Partners), the Partner Coordinator and two Partner Administrators. Due to part time and flexible working arrangements the headcount equivalent is 3.1 fte (full time equivalents).
- 3. The Partner team is responsible for administering the following activities for all 807 HCPC partner roles; recruitment and selection, induction and refresher training, self-assessment for agreement renewal and partner resignations and terminations. In addition the HR Manager (Partners) provides advice and support to both user departments and individual partners on any complaints about partner conduct and/or performance.

Partner Recruitment and Selection Activity
